**Lake County Community Foundation Joins Nearly 800 Foundations Across the U.S.A.  
to Celebrate Giving and Impact During *National Community Foundation Week***

*LCCF Announces 2017 Grants and Honors Local Volunteers and Grantees*

December 12, 2017, WAUKEGAN, IL - During the week of November 12-18, 2017, The Lake County Community Foundation (LCCF) joined nearly 800 community foundations across the United States in celebrating *National Community Foundation Week*. For nearly 30 years, this community celebration has raised awareness throughout the nation about the increasingly important role of community foundations in fostering local collaboration and innovation to address critical civic and economic challenges throughout their communities.

To celebrate locally, LCCF held its Annual Meeting and reception to honor its volunteers and 2017 grantee organizations on Thursday, November 16 at the Byron Colby Barn in Grayslake. Foundation board member and Reverend Dr. Robert Davis fittingly shared a proverb with guests before dinner stating, "If you want to go fast, go alone. If you want to go far, go together."

Grant recipient and President & CEO of the Northern Illinois Food Bank, Julie Yurko noted, "That sentiment is exactly what our organization is all about. By coming together with our partners, we are able to provide 8.6 million meals, right here in Lake County." LCCF's investment is also ensuring families have greater access to fresh produce as well as education on how to prepare nutritious meals thanks to the expertise of Liberty Prairie Foundation's team.

Earlier this year, the Foundation approached Liberty Prairie Foundation and Northern Illinois Food Bank with an opportunity to partner more deeply. The result was a multi-year grant investment that will further the coordination of existing local efforts, inform local food policy and promote and support local, sustainable food production.

For nearly 15 years, LCCF has served as an engine to rally and drive local philanthropy throughout the county. “Partnership is in our DNA,” said Miah Armour, Executive Director of LCCF. “We are always seeking to fund high-impact initiatives and help organizations more efficiently scale their efforts through collaboration.”

“With the season of gratitude and giving upon us, LCCF is pleased to announce its grants for 2017,” said Maggie Morales, who leads LCCF’s grants and community outreach activities. “These investments represent strong partnerships with organizations committed to serving thousands of families across Lake County.”

- **2017 Collaborative Grants** - This year, the Foundation awarded \$110,000 to Liberty Prairie Foundation and Northern Illinois Food Bank to work together to build a better local food system and increase access to affordable, nutritious food across the county. This award is the first under LCCF’s new community investment strategy which is focused on aligning grant funding and community leadership work, ultimately leading to a more streamlined coordination of countywide efforts.
- **2017 Basic Human Needs Grants** address key needs in Lake County: housing, immigrant legal services and violence prevention.
  - Affordable Housing Corporation of Lake County - \$6,000
  - Mano a Mano Family Resource Center - \$5,000
  - Partnership for a Safer Lake County - \$8,000
- **2017 Early Childhood Development Grants** focused on early literacy and providing essential items to families with newborns and infants.
  - Reading Power- \$10,000
  - Twice As Nice Mother & Child - \$10,000 (*new grantee*)
  - Words on Wheels - \$5,000 (*new grantee*)
- **2017 Animal Welfare Grants** support animal adoption and equine therapy in Lake County.
  - Equestrian Connection - \$10,000 (*new grantee*)
  - PAWS Chicago – Glenn L. Felner Adoption Center - \$10,000 (*new grantee*)
